Minutes: The minutes of the **15 July 2021** meeting were accepted as a true record, proposed by Dylan Davies and seconded by Eryl Owain.

Matters arising:

Solar panels: The council has been requested to provide proof that it owns the toilets. The panels were not correctly registered. Waiting for a specialist to provide an energy performance certificate (EPC) exemption and then the panels can be registered.

Sign: Cwm Penmachno / Ffestiniog: Nothing further from the County Council. It was reported that coaches

Wal y Fynwent: Mae pob contractwr yn brysur ar hyn o bryd ond penderfynwyd gofyn eto am bris.

Materion ffyrdd:

Dŵr ar y ffordd ger Park Hill:

Mae'r Cyngor Sir wedi ysgrifennu at berchennog Park Hill. Bydd y Cyngor yn ystyried cymryd camau cyfreithiol os nad ymdrinnir â'r broblem. Penderfynwyd cadw mewn cysylltiad â'r Cyngor Sir.

Pont yng nghanol Penmachno: Nid yw'r Cyngor Sir wedi trwsio'r bont rhwng y Machno Inn a'r eglwys. Penderfynwyd cysylltu â'r Cyngor Sir eto.

Cerbydau'n Goryrru – Ffordd Ysbyty: Adroddwyd bod cerbydau'n teithio'n rhy gyflym i lawr y ffordd i gyfeiriad y pentref. Penderfynwyd gofyn y Cyngor Sir am arwyddion terfyn cyflymder (ategol/bach) wrth ochr yr eiddo Tŷ Newydd Uchaf ac Elusendy.

White Street: The County Council have suggested raising the height of the *No Through Road* sign or moving it to the other side of the road. It was decided to ask for the sign to be moved.

Request for a bench: Cartrefi Conwy are happy for the Community Council to use small plots of land for benches, under licence and provided that all works and insurance is paid for by the Community Council. Decided to discuss further with residents.

Filming in the village: Reported that the company making a Netflix film will be in the village between 13-16 September. The company has made a generous donation to the community.

Cemetery Wall: All contractors are busy at the moment but it was decided to ask again for a quote.

Road:

Flooding on the road near Park Hill:

The County Council have written to the owner of Park Hill. The Council will consider taking legal action if the problem is not fixed. It was decided to keep in contact with the County Council.

Bridge in the centre of Penmachno: The bridge between the Machno Inn and the church has a tree growing through it. Decided to contact the County Council.

Speeding Vehicles – Ysbyty Road: Reported that vehicles are travelling too fast down the road in the direction of the village. Decided to ask the County Council for speed limit repeater signs beside the property Tŷ Newydd Uchaf and Elusendy.

Planning

NP4/29/512 Land adjacent to Tan Y Bryn, Glasgwm Road, Penmachno, Betws Y Coed, LL24 0UF: Proposed erection of dwelling, creation of vehicular access and associated works. Comments received were sent to the park authority. There were no objections.

Other matters

Dog waste: It was reported that people are putting dog poo in the wrong bins such as the school bin. Decided to ask for an additional dog waste bin. The general waste bin on the green is in a poor condition. It was decided to ask the County Council to replace the bin.

Llys Meddyg: A new access has been created to the main road which is potentially dangerous. The County Council and National Park have been contacted.

Machno Inn: A structure has been built behind the pub. It was decided to contact the National Park and to report again the various problems with the site and also to report again the property Swch in Cwm.

Money from the County Council: The Community Council has now received payment from the County Council for clearing public footpaths.

Lack of mobile phone signal: Reported that work has begun on the mast (Emergency Services Network) in Cwm but the lack of mobile phone service remains a problem. It was decided to contact EE to find out if the new mast will provide a commercial service.

Wifi - Neuadd Ty'n y Porth: Reported that the County Council will not install Wifi in the village because they do not own any of the buildings apart from the school. The

Ti a Fi: Reported that the playgroup will be using the hall temporarily. Decided to offer financial support if other options are unavailable.

Brick Wall - Maes y Waen: Concern that children playing on the wall may fall and hurt themselves. It was decided to contact Cartrefi Conwy.

Natural Resources Wales: It was reported that contractors are causing disturbance by driving into the forest very early in the morning. It was decided to invite NRW to the next meeting.

Abandoned vehicle, Llewelyn Street: Reported that an abandoned, untaxed van is still parked on the roadside. It was decided to contact the police, the County Council and to report the fly-tipping behind the van.
