Declaration of interest

There were no declarations

Confirmation of the minutes

The minutes of the **12 September 2024** meeting were accepted as a true record, proposed by Wil Edwards and seconded by Eifion Davies.

Materion yn codi:

Toiled Cyhoeddus: Adroddwyd bod y nenfwd wedi'i ailbeintio ond oherwydd llwyth gwaith presennol y Clerc, ni fu amser i gael prisiau ar gyfer y llawr. Y gobaith oedd y bydd llawr newydd yn cael ei osod yn y flwyddyn newydd.

Cyffordd Ffordd Grenyn gyda'r B4406: Adroddwyd nad yw'r Cyngor Sir wedi gosod drych o hyd. Penderfynwyd cysylltu â nhw eto.

Llwybr Cyhoeddus 55 – Y Waen: Adroddwyd bod y Cyngor Sir wedi gorffen gwaith atgyweirio. Penderfynwyd cysylltu â Cartrefi Conwy ynglŷn â thorri'r gwrych.

Pontrhydgyon / Pont Rufeinig: Adroddwyd bod CNC a'r Ymddiriedolaeth Genedlaethol wedi codi ffensys ac arwyddion ar ddwy ochr y bont.

Diffibrilwyr: Adroddwyd bod y Clerc yn aros am bris gan y Cyngor Sir am gysylltiad trydanol. Roedd trafodaeth wedi digwydd am leoli diffibriliwr yn y blwch ffôn ym Machno Terrace ond mae'r blwch yn dal i gael ei ddefnyddio fel ffôn cyhoeddus.

Agoriad Newydd ar Ffordd Glasgwm: Adroddwyd bod y Cyngor Sir yn rhannu pryderon am y fynedfa newydd. Fel ffordd gyda nifer o ddsbarthiadau, mae'r mater wedi cael ei gyfeirio at Awdurdod y Parc.

Stad yr Ymadawedig: Adroddwyd bod cwmni yn delio â'r ystâd. Penderfynwyd ceisio cysylltu â'r cwmni i gynnig cymorth.

Arwyneb Anwastad – Teras Llywelyn: Adroddwyd nad oes unrhyw atgyweiriadau wedi eu gwneud. Penderfynwyd cysylltu â Cartrefi Conwy eto.

Dympio Asffalt: Adroddwyd nad oes gan CNC unrhyw broblem gyda SP Energy yn dympio asffalt mewn caeau dros dro ar yr amod bod yr asffalt yn cael ei dynnu a bod y caeau'n cael eu dychwelyd i'w cyflwr arferol.

Bws Ysgol: Adroddwyd bod plant yn dal i orfod eistedd ar lawr bws yr ysgol er gwaethaf sicrwydd gan y Cyngor Sir. Penderfynwyd cysylltu â'r Cyngor Sir unwaith eto.

Gwaith Ffordd SP Energy

Mynegodd y Cadeirydd werthfawrogiad o holl waith y clerc dros yr wythnosau diwethaf yn cysylltu â SP Energy

Matters arising:

Public Toilet: It was reported that the ceiling had been repainted but due to the Clerk's current workload, there had not been time to obtain quotes for the floor. It was hoped that a new floor will be installed in the new year.

Grenyn Road Junction with B4406: It was reported that the County Council have still not installed a mirror. It was decided to contact them again.

Footpath 55 – Y Waen: It was reported that the County Council had finished repairs. It was decided to contact Cartrefi Conwy about cutting the hedge.

Pontrhydgyon / Roman Bridge: It was reported that NRW and the National Trust have erected fences and signs on both sides of the bridge.

Defibrillators: It was reported that the Clerk is waiting for a price from the County Council for an electrical connection. Discussion had taken place about locating a defibrillator in the telephone box at Machno Terrace but the box is still in use as a public telephone.

New Entrance on Glasgwm Road: It was reported that the County Council share concerns about the new entrance. As a road with multiple classifications, the matter has been referred to the Park Authority.

Deceased's Estate: It was reported that a company is dealing with the estate. It was decided to try to contact the company to offer assistance.

Uneven Surface – Llywelyn Terrace: It was reported that no repairs have been made. It was decided to contact Cartrefi Conwy again.

Dumping of Asphalt: It was reported that NRW have no problem with SP Energy dumping asphalt in fields temporarily provided that the asphalt is removed and the fields are returned to their normal state.

School Bus: It was reported that children are still having to sit on the floor of the school bus despite assurances from the County Council. It was decided to contact the County Council again.

SP Energy Roadworks

The Chairman expressed appreciation for all the clerk's work over the last few weeks contacting SP Energy and

Mainc ar gyfer Mynwent Arwelfa: Adroddwyd bod aelod o'r cyhoedd wedi gofyn a allai'r Cyngor ddarparu mainc i ymwelwyr. Penderfynwyd ceisio cyllid grant.

Dathliad Nadolig: Adroddwyd bod sawl aelod o'r cyhoedd wedi gofyn a allai'r Cyngor drefnu dathliad Nadolig gyda digwyddiad i droi goleuadau'r Nadolig ymlaen. Cytunwyd i wario £150 ar goeden Nadolig ac adroddwyd bod Awdurdod y Parc wedi cytuno ar grant ar gyfer y digwyddiad.

Llwybrau Cyhoeddus, Cwm Penmachno: Adroddwyd bod cynghorydd wedi derbyn llythyr yn gwneud datganiadau a chyhuddiadau amrywiol ynghylch cynghorydd etholedig arall ac am lwybrau cyhoeddus. Penderfynwyd gwneud ymholiadau pellach.

Adroddiad Cyllidol

Darparodd y Clerc restr o'r holl drafodion ariannol ers y cyfarfod diwethaf i'w dadansoddi.

Adroddwyd nad oedd gan drefnydd angladdau lleol ddigon o arian ar hyn o bryd i dalu am gladdedigaeth.

Cytunwyd bod popeth arall mewn trefn.

Ffioedd Archwilio

Adroddwyd bod Archwilio Cymru yn gyson yn methu â chyfathrebu gyda'r cyngor drwy gyfrwng y Gymraeg. Roedd archwiliad diweddar wedi cael ei filio ar lefel sy'n briodol ar gyfer cyngor gyda chyllideb o fwy na £500,000. Penderfynwyd adrodd Archwilio Cymru i Gomisiynydd y Gymraeg a chysylltu ag Un Llais Cymru am gyngor cyfreithiol.

the contractors and disseminating information to the community which was echoed by members.

It was reported that SP Energy plan to continue burying a new high-voltage cable under the B4406, stopping at Christmas time and starting again in January 2025. Concern was expressed about the diversion along Hafod Rhedwydd Road to Ffestiniog. It was decided to arrange a meeting with SP Energy, their contractors and the County Council.

Correspondence

Bench for Arwelfa Cemetery: It was reported that a member of the public had asked whether a bench could be provided for visitors. It was decided to seek grant funding.

Christmas Celebration: It was reported that several members of the public had asked whether the Council could coordinate a Christmas celebration with an event to switch on the Christmas lights. It was agreed to spend £150 on a Christmas tree and reported that the Park Authority had agreed a grant for the event.

Public Footpaths, Cwm Penmachno: It was reported that a councillor had received a letter making various statements and accusations regarding another elected councillor and about public footpaths. It was decided to make further enquiries.

Financial Report

The Clerk provided a list of all financial transactions since the last meeting for analysis.

It was reported that a local funeral director had insufficient funds at present to pay for a burial.

It was agreed that everything else was in order.

Audit Fees

It was reported that the Audit Wales consistently fail to communicate with the council through the medium of Welsh. A recent audit had been billed at a level appropriate for a council with a budget of more than £500,000. It was decided to report Audit Wales to the Welsh Language Commissioner and contact One Voice Wales for legal advice.
