Confirmation of the minutes

The minutes of the **09 January 2025** meeting were accepted as a true record, proposed by Dylan Davies and seconded by Wil Edwards.

Matters arising:

Public Toilet: It was reported that three companies had been asked for a quote. It was decided to accept Future Flooring's quote for 2.5mm vinyl flooring.

Footpath 55 – Y Waen: It was reported that Cartrefi Conwy had cut the hedge.

Defibrillators: It was reported that the clerk was expecting to hear the result of a grant application soon.

SP Energy: It was noted that the community council had taken a much greater role than expected in liaising with stakeholders. Thanks were expressed to the clerk who had been working under significant pressure. It was reported that SP Energy had appointed new contractors.

It was decided to make new arrangement for liaising with SP Energy before the project restarts.

It was decided to contact SP Energy and ask them to pay the clerk for the 75 hours of unpaid overtime he has worked in the last six months.

Funeral Director: It was reported that the invoice had been paid.

Stable Roof: It was decided to contact the county council.

Audit Wales: It was reported that a letter of complaint had been written and will be sent to Audit Wales, the Welsh Language Commissioner and the Senedd Member.

It was reported that the clerk had received more than 600 emails since January as well as telephone calls and messages through social media.
