Complaint to the Welsh Language Commissioner regarding Audit Wales: The Council received and noted the Welsh Language Commissioner's Decision Notice (CS1329), which found that Audit Wales had failed to comply with Standards 1 and 2 by repeatedly corresponding in English despite the Council's stated preference for Welsh. The Commissioner upheld the Council's complaint in full and has required Audit Wales to take corrective action, including staff reminders, training, and improved procedures for recording and following language choice.
